Management Response – PWFI Mid-Term Review – November 2021

November 2021

Background

This Mid-Term review was commissioned by IUCN and it fulfils its Monitoring and Evaluation Policy to conduct an independent Midterm Review (MTR) for the purpose of learning and reflection on project management and early results. It also addresses Norad's requirement in terms of project evaluation.

The expectation for this review was that the findings and recommendations will help to identify any needed course corrections in the project's approach and activities and bring valuable external reflections to help strengthen the project and complement the MEL system.

IUCN's Management Response, presented here, addresses the 14 recommendations put forward by the reviewers and for which they suggested short- or medium-term actions. This Management Response also addresses the longer-term recommendations suggested by the consultant although tracking of these recommendations will not happen during the remaining lifetime of the PWFI project.
