



# **2022 Report** of the IUCN Species Survival Commission and Secretariat



Stand-alone report IUCN SSC Flamingo Specialist Group The IUCN Species Survival Commission (SSC) is a science-based network of thousands of volunteer experts from almost every country of the world, all working together toward achieving the vision of "a just world that values and conserves nature through positive action to both prevent the loss and aid recovery of the diversity of life on earth."

Members of SSC belong to one or more of near 200 Specialist Groups, Red List Authorities, Action Partnerships, Task Forces, and Conservation Committees that make up the Network, each focusing on a taxonomic group (plants, fungi, mammals, birds, reptiles, amphibians, fishes, and invertebrates), national species, or a disciplinary issue, such as sustainable use and livelihoods, translocation of species, wildlife health, climate change, and conservation planning.

Framed by the Species Conservation Cycle, SSC's major role is to provide information to IUCN on biodiversity conservation, the inherent value of species, their role in ecosystem health and functioning, the provision of ecosystem services, and their support to human livelihoods. This information is fed into the IUCN Red List of Threatened Species.

### 2021-2025 Species Strategic Plan

The IUCN Species Strategic Plan encompasses the joint work of the IUCN Species Survival Commission and a number of partnerships to achieve more than 2,700 targets proposed by the Network during the 2021-2025 quadrennium. To accomplish those targets, the Species Conservation Cycle was established, which is the conceptual framework for the Network activities. The Species Conservation Cycle's main purpose is to guide efforts for valuing and conserving biodiversity through three essential components that are linked to each other:

**ASSESS:** Understand and inform the world about the status and trends of biodiversity. **PLAN:** Develop collaborative, inclusive and science-based conservation strategies, plans and policies.

**ACT**: Convene and mobilise conservation actions to improve the status of biodiversity.

# ASSESS ACT PLAN

Their implementation requires two transversal components:

**NETWORK:** Enhance and support our immediate network and alliances to achieve our biodiversity targets.

**COMMUNICATE**: Drive strategic and targeted communications to enhance our conservation impact.

### **SSC Species Report**

Annual progress in the implementation of the 2021-2025 Species Strategic Plan is documented in the SSC Species Report, which consists of a comprehensive description and analysis of the activities and results generated by the members of the SSC Network each year. Result description: The Flamingo symposium was held at the Pan-African Ornithological Conference PAOC on 25 November 2022, which provided an opportunity to explain about the work of the FSG and assess what support the FSG can offer. Number of presentations delivered in scientific events: 5

Result description: Five presentations on flamingos were delivered at the Pan-African Ornithological Conference PAOC in November 2022 and these presentations highlighted the latest developments in our understanding of intra-African movements of Flamingos, the tools for estimating flamingo populations, and other flamingo conservation issues.

# T-010 Organize and/or attend meetings of flamingo specialists, including the 4th International Flamingo Symposium. (KSR 12)

Number of scientific events coordinated: 1 Result description: Organized a side meeting with African flamingo specialists on 24 November 2022, a great opportunity for furthering collaborations and gaining insight into current projects ongoing in Africa and discussing the proposal for a simultaneous Lesser Flamingo (*Phoeniconaias minor*) survey.
