



Item 1) IUCN Commissions - CEC

#Natureforall Urban Nature:

The #NatureForAll Report on Urban Nature explores what urban nature is, its importance and its benefits on climate as well as on public health.

Reimagine nature communications:

CEC will produce a ten-step guide to creating and implementing a conservation communications strategy that will help NGOs advance their program and project objectives.

Nature education for sustainability:

Production of guides to greening schools in urban settings and to greening education curriculums thus enhancing environmental literacy among students living in cities.

Youth engagement and intergenerational partnerships:

The IUCN CEC Youth Engagement and Intergenerational Partnerships Specialist Group works with the Union to connect and mobilise diverse youth across the world to advocate and act for nature.





Item 1) IUCN Commissions - WCPA

WCPA would like the help of the Urban Alliance to:


- Encourage wider understanding and use of the IUCN Urban Protected Area guidelines;
- Make the most of relevant IUCN knowledge products and tools before developing new ones;
- Update the guidelines and Protected Area criteria in the context of the Global Biodiversity Framework (Target 3 and Target 12); and
- Encourage Parties to the Convention on Biological Diversity to develop national targets for urban protected areas and green spaces in urban settings (GBF Target 12).

- Nature-positive design and urban development

- Development of technical guidelines on Urban Nature-based Solutions
 - Funded by the French Development Agency
 - Guidelines released by April 2025
 - Fundraising needed to organise in-person regional consultation workshops





Item 3) Potential areas for fundraising

- Nature-positive urban development
 - Guidelines for implementation, and expansion to biodiversity outcome monitoring in line with Nature Positive Initiative (halt loss
 of ecosystems and species by 2053, and revert it by 2050)
 - SBTN initiative future development
- IUCN Urban Nature Indexes
 - Roll-out of UNI and support to cities (including communication plan)
 - Maintenance and expansion of web-platform
- Urban ecosystem typology
 - Urban Ecosystem Typology
- Updated guidance on the Urban Protected Areas Guidelines and Site-level tool for identifying other effective area-based conservation measures (OECMs)
- Strengthening of urban nature education
 - Greening educational curricula in schools & youth engagement
 - Supporting cities to strengthen environmental education and communication strategies

Item 5) IUCN Urban strategic work

- IUCN Eight Global Transformations for nature and people
 - Mainstream nature conservation through 8 priorities
 - Sustainable Cities role of IUCN Urban
 - Additional priorities: health, green transition, climate change adaptation and mitigation, blue economy, water stewardship, food systems and finance.

Impact target for urban

Nature-based urban development

- Output: State and sub-national authorities have used biodiversity management and Nature-based Solutions to increase access to green and blue spaces in urban areas.
- Indicator: Count of national and subnational governments with established baseline and targets for nature





Item 5) IUCN Urban strategic work

Marseille Manifesto (2021)

To expand universal access to high-quality green spaces and to enhance urban biodiversity in 100 cities, representing around 100 million citizens by 2025, and assessing their impact according to the IUCN Urban Nature Index.

Reporting on the progress towards this specific target during the next IUCN WCC (Abu Dhabi, October 2025).
