



MEDIA BRIEF AND FIELD TRIP

Sustainable tourism development in the World Heritage Sites

Date: 12 - 14 March, 2018

Introduction

Resolution No. 08-NQ/TW of the Politburo issued on January 16, 2017 sets tourism as a spearhead economy sector with the target of attracting 17-20 million foreign visitors and 82 million domestic tourists by 2020. Compared with these numbers in 2016, i.e., 10 million foreign visitors and 62 million domestic visitors, the target for 2020 is 1.3-2 times higher than the current number of tourists.

Tourism has the potential to make a major contribution to the conservation and development of cultural and natural resources, as well as economic development. However, in several coastal areas, especially inside and close to protected areas and World Heritage Sites, unregulated tourism development is a growing source of concern.

Tourism development that ignores environmental quality and sustainability has already had serious negative impacts. For example, hotels have been built that fragment the habitat of globally threatened wildlife or without appropriate waste water treatment capacity. And solid waste is huge problem almost everywhere in Vietnam.

Within the framework of the USAID-funded Ha Long-Cat Ba Alliance, IUCN will organize a media brief on the topic "Sustainable tourism development in the World Heritage Sites" based on the case study from Ha Long-Cat Ba and following by a field trip to Ha Long Bay and Cat Ba National Park.

Time and location: 12 – 13 March in Ha Long and 14 March in Cat Ba National Park

Objectives:

- Create an opportunity for reporters and journalists to dialogue with local authorities, experts and
 international organizations on the impacts of tourism on environment in general and ecosystems
 in Ha Long-Cat Ba in particular as well as discuss solutions towards sustainable tourism
 development in this area.
- Improve public and policy makers' awareness about the importance of sustainable tourism development in WHS through media engagement.

Target: journalists from Hanoi, Quang Ninh and Hai Phong and other provinces/cities who are interested in environmental and tourism issues.

Languages: Vietnamese and English (with interpreters)
