# IUCN/WBCSD Business and Ecosystems Think Tank

September 8th, 2012 @ IUCN's World Conservation Congress

TO: WBCSD members – active participants at the THINK TANK

DATE: 7 August 2012

**SUBJECT: Agenda, planning & logistics** 

This memo provides context and sets up a process to finalize the active participation of WBCSD members at the Think Tank and to coordinate inputs ahead of this September 8<sup>th</sup> event.

#### **CONTEXT**

The Think Tank is one of the key events on September 8<sup>th</sup>, certainly the main business event that day, and is titled *Changing Pace - scaling up real solutions for Biodiversity & Ecosystem Services (BES)*. Bjorn Stigson, immediate past WBCSD President, will chair the Think Tank - see appendix 1 for the detailed agenda.

Co-convened by IUCN and WBCSD, the Think Tank will challenge business and conservation communities to discuss and debate real, concrete business and public policy solutions. Julia Marton-Lefèvre, IUCN Director General, and Peter Bakker, WBCSD President will open the debate at 11.00 and will be followed by business leaders, who will illustrate effective business action on BES (morning session) and government and financial institution representatives who will elaborate on what are effective public policies (afternoon session). The Think Tank will close at 16:30 following reflections from leading CEOs, representatives from business, NGOs and Indigenous People, as well as the IUCN President.

On September 9<sup>th</sup> at a media event (11:00-11:30), Julia Marton-Lefèvre and Peter Bakker will provide reflections on the Think Tank's deliberations and announce the key themes for IUCN/WBCSD joint work program on business and BES for 2013-2015.

The Think Tank venue can take around 300 participants and we anticipate a full house – including many business participants but with the majority being non-business stakeholders with varying degrees of interest, involvement and concern around business and BES. As business participants you should be prepared to face some degree of critical questioning about business impacts and its role addressing BES challenges and opportunities in general, and the specific impacts and actions of your own company.

# Business Panel (11:20-12:50) - speakers

James Griffiths, WBCSD will be the facilitator for this session - introducing the panel; inviting initial contributions; facilitating a dialogue between panelists; then opening it up to discussion and questions from the floor. Based on discussions to date, the business panel is:

#### **Business Panel (11:20-12:50) – format**

The session is in 3 x 30 minute parts – initial presentations (11:20-11:50); panel dialogue (11:50-12:20) and floor discussion (12:20-12:50).

Following James' introduction of the panel, each panelist has up to 5 minutes to make an initial "thought starter" contribution. Without slides, you will be asked to respond to these points in this initial statement:

- Introduce your company (briefly)
- Outline your company's BES challenges/opportunities
- Profile how your company is proactively responding to these (main focus): Here you might focus on one of more of these types of approaches e.g. target setting; measurement/management/mitigation of ecosystem impacts and dependencies; innovation; supply chain collaboration; participation in sector platforms. Choose one or two of the most progressive and exciting aspects of your work if possible and avoid providing too much detail at this stage.

To assist plan an effective business panel, could each presenter please provide us with a brief indication of the key theme of your initial intervention.

To kick-off the panel dialogue, James will then ask each of you, based on your experience, to comment on strategies to scale and speed up the business response on BES:

- Within your company
- Within your sector
- Across business, industry and society, including public policies

Following the panel dialogue on these points James will open it up for a floor discussion and interaction, most likely with a start-off invitation seeking interventions on priority strategies – or additional strategies - to scale and speed up the business response on BES.

#### Kick-start panel (14:00-14:30)

Chaired by Peter Bakker, in this session titled "Nature +" - a future perspective, four future business and conservation leaders will be invited to provide their own personal views and aspirations on BES challenges/opportunities. The two WBCSD Future Leader Team (FLT) participants will be:

IUCN is locating the two conservation panelists.

#### Final reflections panel (16:00-16:15) - action required by Syngenta & Shell

In this closing session, Peter Bakker will invite final brief personal reflections from a leadership panel of different stakeholder groups. Each panelist is asked to comment on one new learning on BES from the Think Tank and one key recommendation for "changing pace" on BES.

The two CEO level business panelists proposed to date are:

- Syngenta Mike Mack CEO to be confirmed
- Shell, Marvin Odum, President to be confirmed

One representative from the WBCSD's FLT will also share reflections:

 Weyerhaeuser – Edie Sonne Hall, Manager, Environmental Affairs, Sustainable Forests and Products

IUCN is locating the other panelists, which will include Gary Dunning, Executive Director of <u>The Forests Dialogue</u> as the multi-stakeholder platform representative.

To contribute to the final closing session, the CEO panelists should ideally attend the whole Think Tank (from 11:00), as a minimum from the 14:00 kick start panel. Note a bullet point briefing on the business panel session will be available by 14:00 on September 8<sup>th</sup> as an aid – see next section.
